Visitor and Operational Rules of the Into Games Conference

Introductory Provisions

- These Visitor and Operational Rules govern the conditions of participation in events organized by **Into Games s.r.o.** (the "**Organizer**").
- The aim is to ensure the safe, professional, and friendly course of all events, protect health and property, and safeguard the good reputation of the Organizer.
- Every participant is required to respect and follow the instructions of the Organizer, volunteers, and security staff—their instructions are binding.
- These Rules are binding for all participants, visitors, exhibitors, partners, volunteers and suppliers. By attending the event, each participant expresses their consent to comply with these Visitor and Operational Rules.

Entry to the Event

- Participants, teams, and exhibitors must follow the event schedule and comply with instructions regarding installation, use, and removal of equipment.
- All participants must enter only at times specified by the Organizer.
- Entry is permitted only to registered participants or persons holding a valid pass (ticket, accreditation, invitation) and who are 18 years of age or older.
- The Organizer reserves the right to refuse entry to persons under the influence of alcohol, drugs, or persons who may disrupt the event, without any refund of the ticket or fee.
- Upon entry, each participant must check in with the Organizer and, if required, wear a visible identification wristband or badge for the entire duration of the event.

Participant Conduct, Safety and Health Protection

- Each participant must behave respectfully, avoid endangering others, must not disrupt the event, and must maintain order and cleanliness in all areas of the venue.
- Any vulgar, aggressive or otherwise inappropriate behaviour, damage to equipment or technology, tampering with electrical installations, or any activity that endangers property or safety is prohibited.
- Participants must follow all fire, safety and hygiene regulations applicable at the venue.
 - Food and beverages may only be consumed in designated areas.
 - Handling equipment or electrical installations is prohibited. Connecting
 personal devices to the electrical network is not allowed without the technical
 coordinator's approval.
 - Emergency exits, escape routes and first-aid equipment must remain accessible at all times and must not be blocked.

- In the event of an emergency (fire, evacuation, injury), participants must follow the instructions of the Organizer and the Integrated Rescue System.
- Each participant must report any damage, defect or dangerous situation to the Organizer, warn others, and take basic safety measures until the Organizer resolves the situation.
- In case of injury, illness or any extraordinary situation, participants must inform the Organizer or designated staff.

Personal Data Protection (GDPR), Photography, Recording, Media

- The Organizer processes participants' personal data in accordance with applicable legislation (GDPR, Act No. 110/2019 Coll.).
- Data is processed only to the extent necessary for event organization and communication with participants, as defined in the Privacy Policy available at https://intogames.eu/Into-Games-Privacy-Policy.pdf.
- Participants acknowledge that photo and audiovisual recordings may be taken during the event for documentation and promotional purposes of Into Games s.r.o. By attending the event, the participant grants consent to the making and publication of such recordings. More information is provided in the Privacy Policy.
- Participants are prohibited from taking photographs or audiovisual recordings of the event or its parts, including interviews with participants, without their documented consent.

Smoking and Use of Electronic Cigarettes

- Smoking, use of e-cigarettes, heated tobacco devices and similar products is prohibited in all indoor areas of the event.
- Smoking is allowed only in designated outdoor areas marked by the Organizer.
- Violation of this prohibition may result in removal from the event without any refund of the ticket or fee.
- These rules are based on applicable Czech legislation, in particular Act No. 65/2017 Coll., on the protection of health from harmful effects of addictive substances.

Leaving the Event

- All participants must leave the venue only at times specified by the Organizer.
- After the event ends, the premises must be vacated and left in their original condition.
- Participants must leave the venue no later than the time specified by the Organizer.

Disclaimer of Liability

• The Organizer is not liable for injury, loss or damage to participants' personal belongings unless caused demonstrably by the Organizer's fault.

Final Provisions

- Participants are liable for any damage they cause to themselves, the Organizer, or third parties. The Organizer recommends participants have personal accident insurance or liability insurance.
- By attending the event, the participant confirms having read these Rules and agrees to comply with them.
- Participants must also follow internal regulations and operational rules of the venue and comply with the laws of the Czech Republic.
- The Organizer reserves the right to remove from the event any person who violates these Rules or the laws of the Czech Republic, without any refund of the ticket or fees. In serious cases, the Police of the Czech Republic may be called.
- This Visitor and Operational Rules enters into effect on 24 November 2025.
- The Organizer reserves the right to amend or update these Visitor and Operational Rules at any time.
